I. Introduction

By notice dated December 20, 2011 the Federal Energy Regulatory Commission (Commission) issued its “NOTICE OF PRELIMINARY PERMIT APPLICATION ACCEPTED FOR FILING AND SOLICITING COMMENTS, MOTIONS TO INTERVENE, AND COMPETING APPLICATIONS,” for INCA Engineers, Inc., Cortez Pumped Storage Project, FERC No. P-14328-000.¹ The Notice provided 60 days for the submission of filings. II. Motion to Intervene

A. Interest of the Intervenors

American Whitewater is a national non-profit 501(c)(3) river conservation organization founded in 1954 with over 5,000 members and 100 local-based affiliate clubs, representing whitewater paddlers across the nation. American Whitewater’s mission is to

conserve and restore America's whitewater resources and to enhance opportunities to enjoy them safely. As a conservation-oriented paddling organization, American Whitewater has a significant interest in the Dolores River and Plateau Creek, which would be adversely affected by this project. Many of our members live in the region and recreate on the Dolores River and Plateau Creek. Our organization has a direct interest in changes to flows, public access to the river, flow information, native species and habitat, land management, watershed protection and other topics that will arise in the consideration of a hydropower project on Plateau Creek, a tributary to the Dolores River. Based on the interests stated above, American Whitewater hereby requests Intervenor status in the Preliminary Permit Application in this filing.

B. Grounds for Intervention


Intervention by American Whitewater is in the public interest as required by 18 C.F.R. §385.214(b)(2)(iii). American Whitewater has significant and undeniable interests in the preservation of Plateau Creek and the Dolores River's natural, recreational, cultural and streamflow-dependant resources. No other parties to the proceeding will be able to adequately represent those interests and therefore American Whitewater has a direct and substantial interest in the outcome of this proceeding.

III. Conclusion

American Whitewater strongly objects to the development of the Cortez Pumped Storage Project due to the significant negative impacts on the recreational, aesthetic, habitat and ecological values of Plateau Creek and the Dolores River.

We respectfully request that the Commission grant American Whitewater's Motion to Intervene, establishing standing for our organization in the proceedings related to INCA Engineers, Inc., application for Preliminary Permit for the proposed Cortez Pumped Storage Project.


